#### C. SECRETARY:



## MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustee must meet atleast once in every calendar quarterly and may meet more often when required.

- The meeting of Board of Trustees shall be convened by the Managing Trustee and he shall preside over the meetings. ### VIII. INVESTMENT OF TRUST FUNDS:

# IX. ACCOUNTS AND AUDIT:

- The Board of Trustees shall maintain true an correct accounts of the Trust.
- The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

## X. AMENDMENTS:

- 1. While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust, the First Managing Trustee and First Trustees, at a duly convened meeting of the Board with at least 2weeks notice, and by resolution passed by atleast three-fourths majority of the Board of Trustees present and voting. The amendments to this Trust deed, can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.
- If any alteration or amendment or amendments is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the Commissioner of the Income Tax and these shall be read together with the main Trust deed.


#### XI, INDEMNITY:


